Brunswick native takes charge at nursing care, rehab facility

Chase City Health & Rehabilitation Center has welcomed a new administrator — Robin S. Parrott, a Brunswick County native who joined the long-term nursing, respite and short-term rehabilitation center in December.

Parrott was named administrator at Chase City after recently completing her licensure as a Long Term Care Administrator in 2015. She holds a degree in the field from Mary Baldwin College, having made the transition from a long-time background in social work and admissions.

In June of 2015, she completed her degree require-

ments at Mary Baldwin College and passed her boards in July to become a licensed Long Term Care Administrator.
